Founder and director, On Think Tanks



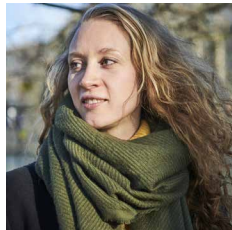

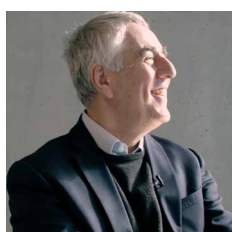

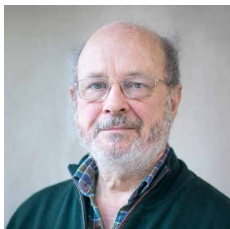

He has written on a range of subjects, including trade policy capacity building in Sub-Saharan Africa, the effectiveness of think tanks in bridging the research-policy gap, and on the challenges of public engagement for think tanks.

Director of communications and publishing, Chatham House

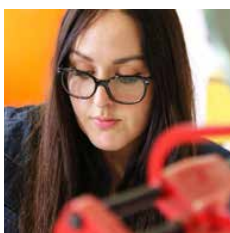
