Registration fees and currency

OTT is registered in the United Kingdom. As such, the registration fees for the conference will be collected in GBP (approximate USD equivalent provided below).

- Group A - Nominal fee: 160 GBP (approx. 200 USD)
- Group B - Reduced fee for selected countries: 80 GBP (approx. 100 USD)
- Group C* - Nominal fee for UK participants: 160 GBP + 20% VAT (approx. 200 USD + 20% VAT)

**Note for participants based in the United Kingdom: In accordance with the United Kingdom tax law, OTT is obliged to charge and collect VAT on taxable goods and services. OTT will provide tax invoices to all Group C ticket buyers.*

Refund policy

Conference attendees may request refunds up to 30 days before the event starts, i.e., up to **22 April 2024**.
