## Payment policy

Starting in 2024, we took a step towards securing the long-term viability of our conferences by introducing a nominal registration fee for the OTT Conference.

This contribution enables us to foster greater diversity in participation, and enhance the sustainability of our conferences. As always, we aim to make the OTT Conference a valuable experience for you!

In this document you will find information about the registration fees and our refund policy.

## Registration fees and currency

OTT is registered in the United Kingdom. As such, the registration fees for the conference will be collected in GBP (approximate USD equivalent provided below).

Nominal fee (Group A)	160 GBP (approx. 200 USD)
Reduced fee (Group B)	80 GBP (approx. 100 USD)
UK participants (Group C)	160 GBP + 20% VAT*

*\* In accordance with the UK tax law, OTT is obliged to charge and collect VAT on taxable goods and services. OTT will provide tax invoices to all Group C ticket buyers.*
