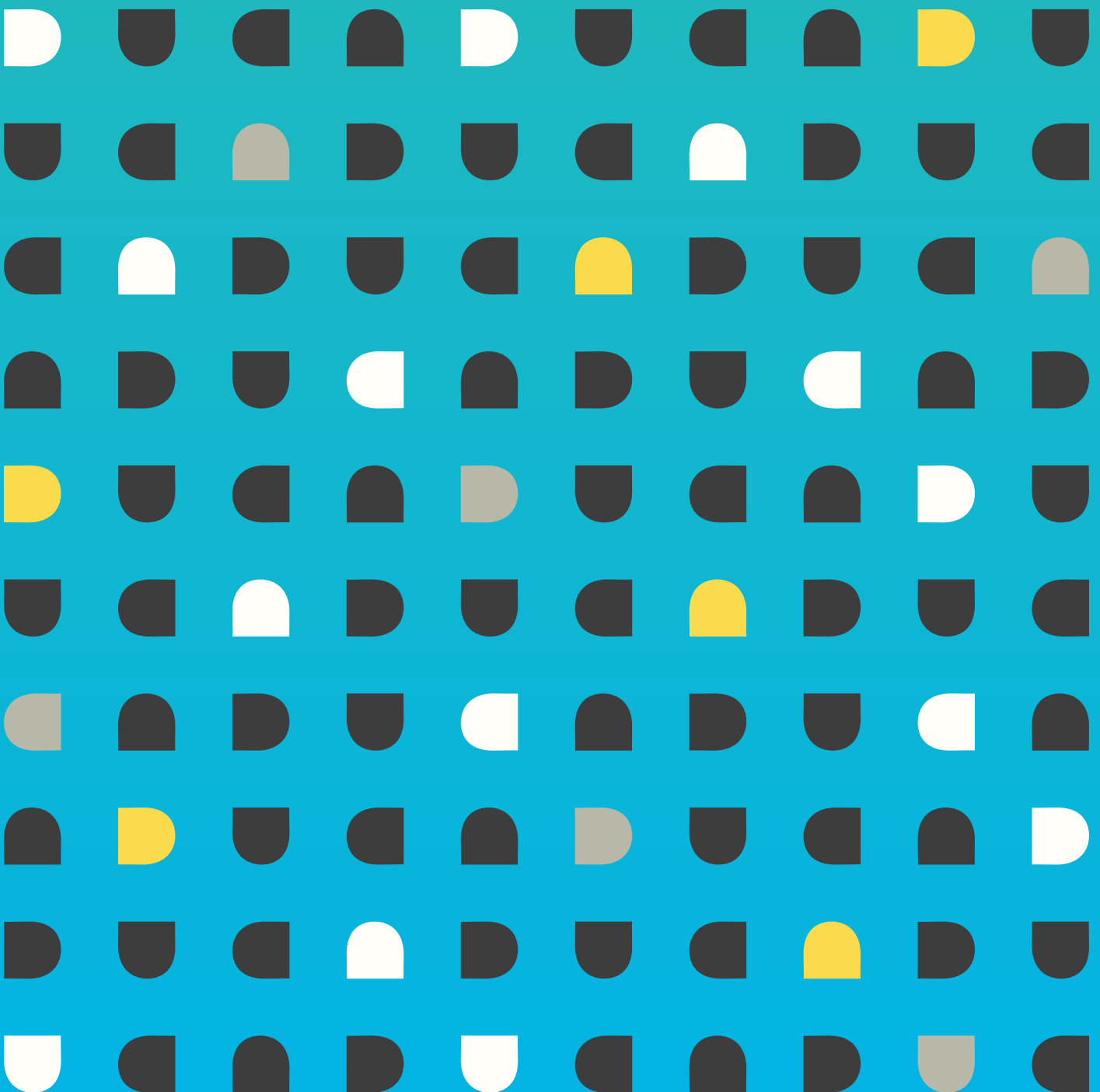




100 Think Tanks

Introduction

The 100 Think Tanks to Watch 2025 is a peer-recognition exercise based on nominations received from other think tanks and sector professionals. Its purpose is to highlight organisations that, in the perception of relevant actors, have implemented noteworthy practices, innovations, or impactful work.

This list is **not a ranking**; it is **not a list of the “best” think tanks**. No technical performance, output, or impact assessment criteria were applied. Inclusion is based exclusively on nominations, with recognition coming from peers and members of the OTT community, rather than from an independent evaluation.

At OTT, we have reflected on the impact of think tank rankings and the challenges associated with their development. Through this list of think tanks to watch, we wish to both celebrate think tanks and encourage collaboration within the community. Every year, we expect the list to change, and the information shared about each think tank to be better, more insightful and more useful.

The document lists organisations by subregion—based on their headquarters location and, where relevant, their primary geographic focus—and alphabetically within each subregion. It also includes role-based tags that allow users to search for similar actions among think tanks. You can search the database here: onthinktanks.org/100towatch. They were asked to share up to three examples of practices, initiatives, or impacts from the last year, explain their significance, and provide verification links (e.g., publications, project pages, media coverage). Organisations that did not respond to the survey are marked with an asterisk (*) in the final list. **We acknowledge we did not have enough time to follow-up to facilitate a response.** In these cases, the OTT team collected relevant information from their official websites and based on their knowledge of the think tank to develop the final blurb. **For future editions of the list we will allow more time for think tanks to respond.**

ANA's [work on the links between creativity and productivity gained international traction](#), with the OECD inviting it to present in 2025 as part of its global project on innovation. Its [Middle Australia study](#), a three-year focus group initiative, captured how everyday Australians value culture in their lives and continues to be cited by politicians. ANA has also contributed to the creation of cultural policies across jurisdictions, [laying the foundation for a 10-year national strategy](#). As one of the few global think tanks focused primarily on culture, ANA deserves close attention.

In 2025, the [Metro Monitor](#) assessed the performance of U.S. metropolitan economies across dimensions such as growth and racial and geographic inclusion. Its [Reconciliation 2025](#) series analysed the U.S. budget reconciliation law and its implications for debt, health, and fiscal policy. On global economics, Brookings published [The search for a new global safe haven](#), examining which countries could emerge as financial refuges amid shifting international markets. Brookings bridges academic insight with real-world policy challenges, making it one of the most cited and influential think tanks globally.

It has developed a [tool to learn how applied ethics strategies](#) could accelerate climate action implementation. The Council also operates the Carnegie [Ethics Accelerator](#), an incubator that applies ethical frameworks to rapidly evolving issues such as AI, authoritarianism, and climate change. Complementing this, the [Ethics Fellowship](#) trains young professionals from business, government, and civil society to apply ethics to practice, fostering a new generation of values-driven leaders. These initiatives underscore the Council's mission to place ethics at the heart of international cooperation and global problem-solving.

Chatham House is a policy institute that helps governments and societies build a secure, prosperous, and just world. Known for shaping debates on global issues such as Russia's invasion of Ukraine and energy security, it combines convening power with influential research. [The World Today](#) magazine brought Chatham House's work to life with accessible analysis, new interactive features, and record readership ahead of the 2024 US elections. Its longstanding work on [UK-China climate cooperation](#) produced a widely cited 2025 policy paper that informed government dialogue and contributed to an official bilateral MOU on climate. With its tradition of open debate under the Chatham House Rule and a rich events calendar, it continues to set standards for policy influence and public engagement. Chatham House is a staple of any list of think tanks to watch.

E3G is an independent climate think tank with a global outlook, working to translate climate politics, economics, and policy into action. It co-founded [London Climate Action Week](#), which has grown into the world's largest city-based climate event, with 750 events in 2025 and direct links to the COP30 in Brazil, inspiring similar weeks globally. Internationally, E3G played a key role in negotiating the [Baku to Belem Roadmap](#), bridging positions on climate finance and charting [a path to mobilise \\$1.3 trillion annually for developing countries](#). Domestically, its sustained advocacy secured the UK's [£13.2bn Warm Homes Plan](#), a landmark victory for decarbonising home heating. These examples illustrate E3G's influence, spanning from local to global arenas.

Ember is an independent think tank that accelerates the clean energy transition using open data, trusted analysis, local expertise, and a global outlook. Its [Global Electricity Review 2025](#) provides a comprehensive assessment of how global electricity generation changed in 2024, underpinning accountability in energy transitions. Its report [New lines of defence: how inter-connectors keep the lights on](#) shows how cross-border grid links mitigate blackouts, making the case for infrastructure investment. In India, [Ember revealed battery storage](#) in power exchanges became profitable for the first time in 2024, highlighting how cost declines shift markets. These examples demonstrate how Ember transforms high-quality data into policy narratives and tools that drive clean energy action globally.

[The Orange Book](#) helps to lift the calibre of policy debate in the lead-up to elections and focuses the national conversation on the long-term challenges facing the country. This is an excellent example of how think tanks can aim to set the policy agenda for the year ahead—and not just act as expert commentators.

The Heritage Foundation is a think tank that promotes policies rooted in free enterprise, limited government, individual freedom, traditional American values, and strong national defence. Its advocacy arm, [Heritage Action for America](#), works with lawmakers and mobilised nearly 20,000 Sentinel activists and over 2 million grassroots supporters to push Heritage policy solutions. Through [Project 2025](#), Heritage led a coalition of more than 70 conservative organisations to prepare a policy agenda, personnel, training, and a 180-day playbook for a future conservative administration. We may disagree with some of the recommendations and how these are being implemented, but the strategy to create a detailed plan and roadmap for the incoming government is worth learning from: policymakers do not just need recommendations, they need help making them happen.

IFS is an independent economics research institute. Its world-class research helps policymakers – and those who hold them accountable – understand how policy decisions affect individuals, households, and businesses. Major initiatives include the [Mirrlees Review](#), which set out principles of a fair and efficient tax system; [the annual IFS Green Budget](#), providing independent analysis of trade-offs ahead of the Budget; and [the Deaton Review of Inequalities](#), a landmark study led by Sir Angus Deaton. The IFS has perfected the art of using a window of opportunity: when the British Government publishes its budget, all eyes turn to its analysis, making it arguably the most important body holding the government to account on financial matters.

Jamestown has established a large global contributor network, particularly across Eurasia, and provides timely, unfiltered analysis of conflict, security, and geopolitical dynamics. Its expertise is routinely used by U.S. government actors and external partners.

The Lowy Institute is an independent, nonpartisan international policy think tank. It combines high-quality research, events, and public engagement with a global and Asia-Pacific focus. Flagship initiatives include the [Indo-Pacific Development Centre](#), which generates policy insights on climate finance, digital economies, regional integration, and development finance, and hosts the interactive [Pacific Aid Map](#) to track ODA in Pacific nations. Its [International Security Program](#) monitors strategic and security dynamics in the Indo-Pacific region. A hallmark project is the [Asia Power Index](#), which ranks 27 countries and territories across 131 indicators of power, spanning military, economic, diplomatic, and cultural dimensions, and offers an interactive tool to track shifts in Asia's balance of power. Together, these initiatives demonstrate how Lowy shapes public discourse, policy debates, and Australia's voice in the world.

Working across several countries, it combines creative polling with practical advice for political stakeholders. In the [2025 England local elections](#), its research anticipated Reform UK's rise and shaped national narratives. Its [Progressive Activists report](#) influenced civil society and media, while over 25 events at the [2024 party conferences](#) strengthened its convening role. Through work like [Shattered Britain](#), More in Common is addressing the worsening political context most think tanks overlook.

In the past five years, it has restructured to prioritise impact over growth and inequality, gaining independence to take bold positions, such as condemning the genocide in Gaza. It has supported the African Continental Free Trade Area by embedding experts, assisting committees in Nigeria and Ghana, and advancing key investment and [digital trade protocols](#). Through its partnership with NEAR, ODI has [reframed humanitarian action as governance](#) and co-founded a [coalition to reform tax expenditures](#), raising them to a key fiscal priority. Its restructuring offers lessons in strategic focus, impact, and tackling inequality.

The Vera Institute of Justice is a national organisation focused on ending mass incarceration, advancing dignity and fairness in justice systems, and promoting evidence-based policy solutions. In 2025, Vera updated its [ICE Detention Trends dashboard](#) to expose record levels of immigration detention, analysing millions of new records to enhance public accountability. That same year, [it joined a coalition to file a class-action lawsuit](#) challenging the Department of Justice's abrupt termination of \$820 million in grants for community violence intervention and criminal justice reform programs. Through its [Unlocking Potential initiative](#), Vera scales high-quality postsecondary education in prisons, helping expand access and reduce racial inequities in educational outcomes behind bars. These initiatives show how Vera combines rigorous research, public tools, legal advocacy, and institutional partnerships to influence policy, mobilise accountability, and reshape incarceration in the U.S.

QI is a think tank that advances a foreign policy centred on diplomacy and military restraint. In 2025, it launched the [Think Tank Funding Tracker](#), a first-of-its-kind searchable database exposing foreign government, defence contractor, and U.S. government funding of think tanks—praised by journalists, policy-makers, and members of Congress. QI also convened the [Better Order Project](#), bringing together 130 global experts to propose alternatives to great power blocs and strengthen multilateralism. Its [Global South Program](#) promotes U.S. engagement with rising states through diplomacy and cooperation rather than coercion. By pushing for transparency, inclusivity, and restraint, QI is reshaping the debate on U.S. foreign policy—making it one to watch.

CAPS Unlock is a regional think tank that emerged after the withdrawal of the Open Society Foundations from Central Asia. Its leadership took the chance to develop a new institution—a regional think tank—that would be able to mobilise resources and attention towards the region. In a short time, it has positioned itself through independent research, high-level regional events, and global partnerships, despite operating in a hostile political environment. In 2025, it co-authored a landmark report with the [Internet Society on Kazakhstan's internet infrastructure and surveillance](#), combining rigorous analysis with public engagement. It also translates major works, such as [Adeeb Khalid's Central Asia: A New History](#), into Kazakh, and runs a [popular weekly podcast](#) that amplifies Central Asian voices. These initiatives demonstrate how CAPS Unlock is reshaping narratives and building regional intellectual leadership.

It convenes intergovernmental dialogues, produces analytical reports, and engages with global forecasting platforms. In 2025 it [hosted a meeting with the Central Party School of China to deepen bilateral strategic ties](#); participated in the [Valdai International Discussion Club](#) to connect Uzbek perspectives to global debates; and [signed an MoU with the Saudi Gulf Research Center to expand regional research partnerships](#). Through its [Young Analysts Club](#) and regular publications (monographs, analytical reports, policy briefs), ISRS helps shape Uzbekistan's foreign policy and development agenda.

Paperlab is a think tank that combines independent research with innovative platforms for dialogue and talent development. Its flagship [discussion platform](#) convenes government officials, critics, researchers, and civil society in open debate—moving beyond the traditional “publish and pray” model and creating a feedback loop that compels policymakers to engage with evidence-based arguments. In 2022, Paperlab launched the [Central Asian Think Tanks Forum](#), now an annual gathering that fosters regional collaboration on democracy, human rights, and foreign policy. Through its [Making New Experts school](#), it has also pioneered a structured program to train and mentor emerging analysts, ensuring a sustainable expert community for the region. PaperLab dares to tackle some sensitive topics and introduce fresh perspectives on political and economic developments in a challenging political environment.

CIPS is an independent, non-profit think tank that advocates for practical reforms to expand civil, political, and economic freedoms. Its research and advocacy have influenced major policy changes, including the redesign of fertiliser subsidies into [Direct Fertiliser Assistance](#), reflected in Presidential Regulation No. 6/2025 and pilots that will improve efficiency, digital inclusion, and farmer agency. Through its [Learning Hub](#), CIPS translates policy research into classroom-ready videos, briefs, and guides that help students and lecturers engage with issues such as food security, digital literacy, and entrepreneurship. Its [study on Indonesia's OECD accession](#) projected investment gains and sectoral transformation, offering a timely roadmap for policymakers and investors. By combining rigorous analysis with effective advocacy, CIPS has become a key voice in Indonesia's policy debates.

IDEAS is a non-profit think tank advancing a competitive economy, trust in institutions, and an inclusive society. It has tackled the sensitive issue of political party financing, working with the [All-Party Parliamentary Group on Political Financing](#) to promote transparency, an approach that shows the potential of constructive engagement with political actors. Its [Orang Asli Education Research Series](#) amplifies Indigenous voices and has informed policy debates on inclusive education. In climate policy, IDEAS' [paper on carbon pricing for Malaysia's steel industry](#) comes as the country prepares its 2026 reforms. A think tank to watch for its ability to combine sensitivity, inclusivity, and timeliness in policy impact.

KRI conducts research on national issues and recommends policies to improve the well-being of Malaysians. Its flagship [State of Households 2024 report](#) analysed how the pandemic reshaped incomes, expenditure, poverty, education, and digital health, disaggregated down to the district level to expose disparities hidden in national averages. In housing, KRI's long-standing advocacy for a Build-Then-Sell system has informed reforms announced in the 13th Malaysia Plan, [strengthening protections for homebuyers and reducing abandoned projects](#). KRI has also advanced [an inclusive care policy](#) through mixed-methods research, linking previously overlooked voices, such as housewives, to policy debates. These examples show how rigorous evidence and engagement can inform more equitable policymaking.

MyPACK is a research hub providing policymakers with innovative solutions to the Myanmar crisis, drawing on a global network of researchers, practitioners, pro-democracy groups, and diaspora communities. In 2024, it supported [Greg Constantine's Ek Khaale photojournalism project](#), exhibited at the University of Toronto, and co-organised events with student groups and Myanmar diaspora organisations. Rather than framing the Rohingya in isolation, the initiative created a space for Rohingya and non-Rohingya communities to share experiences of belonging and exclusion in Myanmar. MyPACK is not deterred by the political context in Myanmar. Instead, it is mobilising a network of on-the-ground researchers, practitioners, pro-democracy organisations, and diaspora around the world to undertake research, organise events and advocate for reform. For think tanks interested in learning how to work collaboratively and funders looking to work in complex environments, MyPACK is one to watch.

The SMERU Research Institute is an independent think tank with experience in poverty, inequality, social protection, and human development. It started with a focus on poverty reduction but has adopted new policy challenges as the country's income has risen. Most recently, it has published a [series on the Socioeconomic Impact of the COVID-19 Pandemic](#)—nine sub-studies that monitor how households were affected and how government policies in health, labour, and education responded. It also released [Don't Give Up Facing All of This: Children's Experiences during COVID-19](#), documenting how children perceived and coped with the crisis. Beyond the pandemic, SMERU has engaged in forward-looking work on [Accelerating Digital Skills in Indonesia](#), aligning its research with national development priorities in digital transformation. With rigorous evidence, inclusive orientation, and capacity building, SMERU remains one of Indonesia's most trusted voices in public policy.

Among its recent works, TDRI has published [TDRI Insight](#) commentaries on climate and urban resilience. It also convenes interdisciplinary research teams (16 research teams) covering fields such as inclusive development, sustainable energy, and innovation policy. With its breadth of expertise, rigorous methods, and sustained engagement with Thai public agencies, TDRI continues to be one of the region's most respected policy institutions.

In 2025, SDPI's Energy Unit released a landmark study on *the EU Carbon Border Adjustment Mechanism*, translating trade policy into sector-level decarbonization pathways for Pakistan's industries. Through its Governance and Reforms Unit, it launched a *Data Governance Framework* to harmonise national and provincial statistical systems and promote open data. Under the *Raising Her Voice project*, SDPI also advances women's representation in political party leadership through political economy research, structured consultations, and public advocacy. Together, these initiatives illustrate SDPI's ability to link rigorous research with actionable reforms that shape Pakistan's future.
